RULES

- 1. Documents required :
 - a) Photocopy of Birth Certificate (Duly attested by Gazetted Officer).
 - b) Two passport size photographs to be affixed.
 - c) Photocopy of Transfer Certificate of previous school.
 - d) Photocopy of the current Report-Card.
 - e) If admission is sought in class IX or X a certificate of the 3rd language passed in class VIII.
- 2. Transport facilities will be provided by the school on existing routes only. It will be the responsibility of the parent/guardian to drop/collect the child from the specified bus stop. Transport once provided will not be discontinued during the session.
- 3. Fees are payable for twelve calendar months of the year. It is to be paid every third month, four times a year. The fee will have to be paid by the 15th of the relevant month. A late fee of Rs. 50/- per day will be charged after the 15th. Only cash payment shall be accepted after the due date along with the late fee charges.
- 4. All fees will be deposited either by cash or by cheque in favour of "**Rabindranath World School**" at the Accounts department of the School.
- 5. If the parents have deposited fees for a student and child has not attended school even for a day, only caution money will be refunded. **Other charges shall not be refunded**.
- 6. One calendar month's notice will be given (when the child is in school) before a child is withdrawn. If withdrawn without notice, two months fees will be charged in lieu of one months notice. This is applicable to all students whether new admission or existing students.
- 7. A child can be removed on grounds of :
 - a) continued absence without information
 - b) gross indiscipline
 - c) non payment of fees for one month.
